**Sub: Publication of Applications u/s 64(2) of the Electricity Act, 2003, read with Reg. 53(7) of the OERC (Conduct of Business) Regulations, 2004 for Revenue Requirement and Retail Supply Tariff Application for the FY 2014-15 filed by Western Electricity Supply Company of Odisha Ltd (WESCO) before the Odisha Electricity Regulatory Commission, Bhubaneswar.**

Sir,

With reference to your application dated **30.11.2013** before the Commission in respect of Revenue Requirement and Retail Supply Tariff for the Financial Year 2014-15, which has been registered as **Case No.86/2013**, I am directed to say that the Commission have decided to dispose of the above application through a public hearing.

- 3) You are required to arrange for facilitating inspection/perusal and prompt supply of copies of Revenue Requirement and Retail Supply Tariff Application for the year 2014-15 as mentioned in Para (1) of the Public Notice.
- 4) Salient features of the Revenue Requirement and Tariff Applications as mentioned in Para (1) of the Public Notice shall be made available to the interested persons from the offices mentioned at Para (2) of the enclosed notice on payment of the photocopying charges, **(Rs50/-)** on or before **15.01.2014**.

The said salient features as submitted by the licensee shall include:-

- i) write up on the application,
  - ii) calculation of expected revenue from existing and proposed tariff,
  - iii) information on subsidy,
  - iv) calculation of revenue requirement,
  - v) balance sheet
  - vi) profit & loss account.
- 5) Interested persons may obtain a full set of the Revenue Requirement and Retail Supply Tariff Application for the year 2014-15 from your offices as mentioned at Para (2) of the enclosed notice on payment of the photocopying charges, (Rs.200/-) during the office hours on or before **15.01.2014**.
- 6) It may please be noted that you may file a consolidated rejoinder to all the suggestions/objections filed by the interested persons and admitted by the Commission, on or before **20.01.2014**.
- 7) The proof of the above publications in English and Odia dailies shall be furnished to the Commission within seven days of such publications.

**Publication of Applications u/s 64(2) of the Electricity Act, 2003, read with Reg. 53(7) of the OERC (Conduct of Business) Regulations, 2004 for Approval of Annual Revenue Requirement and Determination of Retail Supply Tariff for the FY 2014-15 filed by Western Electricity Supply Company of Odisha Ltd (WESCO) before the Odisha Electricity Regulatory Commission, Bhubaneswar**

1. **Western Electricity Supply Company of Odisha Ltd (in short WESCO)**, holder of the **Odisha Distribution and Retail Supply Licensee, 1999 (4/99)**, a deemed Distribution Licensee under **Sec. 14 of the Electricity Act, 2003** has submitted its Application to the Odisha Electricity Regulatory Commission on **30.11.2013** for approval of its **Revenue Requirement and determination of Retail Supply Tariff for the financial year 2014-15**, which has been **registered as Case No.86/2013**. The application has been filed under Section 62 and other applicable provisions of the Electricity Act, 2003 read with OERC (Terms and Conditions for Determination of Tariff) Regulations, 2004 and OERC (Conduct of Business) Regulations, 2004. The Commission have decided to dispose of the case through a public hearing.

- (a) The suggestions/objections should be filed in six copies and should carry full name and postal address of the person/ organizations/ institutions sending the suggestions/objections and shall be supported by an affidavit.
  - (b) There shall be clear indication if the suggestions/objections are being filed on behalf of any organization/institution representing any category of consumers. It should also be specifically mentioned if it is to be heard in person by the Commission.
  - (c) Suggestions/objections received after the date mentioned above or those which will prove deficient on any or more of the above points may not be admitted for hearing. Only those objections/suggestions supported through affidavit will be taken up for hearing.
7. As directed by the Commission, the date & place of public hearing shall be duly published in the news papers and also be communicated to the parties whose objections are admitted.
